Scope of Work

- Capacity Development is conducted through strengthening the Communication Forum of Local Governments and Legislatures of Aceh/*Forum Komunikasi Pemerintahan Kabupaten/Kota se-Aceh* (FKKA)
- Capacity Development of FKKA is conducted in coordinating various support of TKPPA to establish and facilitate the Aceh Education Sector Working Group's activities/*Kelompok Kerja Regional Sektor Pendidikan* (RESWG) in 5 regions consisted of 17 districts/ municipalities.

Purpose of RESWG Establishment

- To build synergy and harmonization in the development of education sector between provincial and district/municipality governments, intergovernmental districts/municipalities and education stakeholders.
- To facilitate the implementation of strategies and policies that has been formulated by TKPPA
- To facilitate the socialization of Aceh Government Policies relating to Districts/Municipalities

What RESWG Do?

1. Forum for Education sector stakeholders to conduct research, analysis and provide feedback to educational policies of all level governments; national, provincial and districts / municipalities
2. Forum for the dissemination of information and sharing experiences related to education policy to all education stakeholders across the Districts / Municipalities
Forum for facilitating the implementation of education strategies and policies

Stages of RESWG Policy Dialogue

1. Establishment of stakeholder involvement
 - a. Ensure the involvement of key stakeholders
 - b. Assign of Coordinator
2. Setting policy priorities to be discussed
 - a. Strategy and policy that has been formulated by TKPPA
 - b. Determine agenda of discussion
3. Conduct policy discussions:
 - a. Collecting various data/studies & analyzing the condition of education
 - b. Conduct discussion to gather all stakeholder's opinion
 - c. Promote understanding on duties and functions of each stakeholders
4. Formulation of policy recommendations in the form of feedback or develop measures in the implementation of discussed policy
